ANNOUNCING A COMPETITIVE ENTRANCE EXAMINATION FOR ADMISSION INTO THE MASTER  
PROFESSIONNEL CYCLE OF THE REGIONAL TRAINING CENTER SPECIALIZED IN AGRICULTURE (CRESA)  
FORESTRY AND WOOD IN THE FACULTY OF AGRONOMY AND AGRICULTURAL SCIENCES (FASA) OF THE  
UNIVERSITY OF DSCHANG FOR THE 2016/2017 ACADEMIC YEAR.

Mindful of the Protocol Agreement between ACCT, AUPELF-UREF and the Ministry of Higher Education of  
16th of July 1993, laying down their role in the creation and functioning of the Regional Training  
Center for specialized training in Agriculture (CRESA) Forestry and Wood at the University of  
Dschang;  
Mindful of the Agreement N°05/1336/L/MINESUP/DDES/PEEX/esc of 22<sup>nd</sup> March 2005 creating the  
Environmental Impact Assessment Training Programme in CRESA  
Mindful of Order N°16/172/MINESUP/SG/DAUQ/SDEAC/SE of 10<sup>th</sup> February 2016 setting dates for  
competitive entrance examinations for admission into Faculties and Schools of State Universities for  
the 2016/2017 academic year ;  
On the proposal of the Rector of the University of Dschang ;

**HEREBY DECIDES AS FOLLOWS:**

*Article 1<sup>er</sup>.*- A competitive entrance examination based on study of files is open for admission of sixty (60)  
students into the fifth year of the PROFESSIONAL MASTER cycle of the Regional Training Center of  
Specialized study in Agriculture (CRESA) of the Faculty of Agronomy and Agricultural Sciences (FASA) of the  
University of Dschang for the 2016/2017 academic year.

*Article 2.-* This competitive entrance examination concerns the three following programs:

1. Industrial Valorisation of wood

2. Management and Participative Management of Forestry Resources
3. Environnemental Impact Assessment.

The 60 places opened are distributed as follows:

- 10 for Industrial Valorisation of wood
- 15 for Management and Participative Management of Forestry Resources
- 35 for Environnemental Impact Assessment.

**Article 3.-**

(1) The entrance examination is open to candidates of both sexes, Cameroonians and Citizens of other African francophone countries and Indian Ocean mastering perfectly French language. There is no age limitation.

(2) Candidates should commit themselves to pay tuition fees of 1,000,000 (one million) CFA F, and other charges of their cost of living.

(3) The training in CRESA is at the fifth year level of the PROFESSIONAL MASTER, and last one year (12 months). Candidates must be holder either of a Master I (Maîtrise), or an Ingénieur diploma (BAC + 4 years or more), or an equivalent Certificate in the following fields:

- *For Industrial Valorisation of wood*
  - Ingeneering sciences : civil, ingeneering, mecanical ingeneering, industrial ingeneering,
  - Forestry Sciences
  - Forestry Ingeneers,
- *For Management and Participative Management of Forestry Resources*
  - Forestry Ingeneers
  - Agro-economists,
  - Plant Biology
  - Geography
- *For Environnemental Impacts Assessment*
  - Environnemental Sciences,
  - Physics
  - Chimistry
  - Forestry
  - Agronomy,
  - Economics
  - Law,
  - Humanities: Geography, Sociology, Anthropology, Psychology.
  - Soil Sciences
  - Ingeneering sciences

**Article 4.-** The application file will include the following:

- An application form obtainable available at CRESA (Yaounde Nkolbisson); from the web site of the University of Dchang (<http://www.univ-dschang.org>); on the web site of Ministry of Higher Education : <http://www.minesup.gov.cm> ; and in Francophone Numeric Campuses of the «Agence Universitaire de la Francophonie» (AUF)
- A certified-true photocopy of birth certificate (issued not more than 3 months old);
- Two passport photo (4x4)
- A medical certificate
- A certified-true photocopy of all university diploma obtained.
- Certified-true photocopy of transcripts and the diploma presented for admission,
- For civil servant candidates, a letter signed by the employer to give the candidate authorisation to apply
- A large (A4 size) self addressed stamped envelope (postage determined by the weight of the file).
- The receipt of a 20.000 (twenty thousand) CFAF application fees through postal money order addressed to the Responsible of the Administrative and Financial Service of CRESA Forêt-Bois. Or a receipt of the same amount issued at the "Société Générale de Banque au Cameroun, Agence Hôtel de Ville Yaoundé " at the account N° 22 0000 41764 /25.

The deadline for application is **Friday 30 september 2016**.

*Article 5.-* Only candidates with a full and complete application file will be considered.

*Article 6.-* the competitive examination on the basis of file study is based on the evaluation of formal performance of candidates on the following criteria.

- Transcripts concerning the highest diploma;
- University Coursus (or class repeat) ;
- Academic internships;
- Academic Memoir ;
- Professional Experience ;
- Internships or professional seminars;
- Thematic Project in the chosen section (justification, objectives, methodology, expected results), motivations and perspectives.

*Article 7.-*


1) The results will be compiled and prepared by a panel appointed by the Minister of Higher Education on the proposal of the Rector of the University of Dschang.

2) Final results are published by the Minister of Higher Education

*Article 8.-*

The Rector of the University of Dschang, The Director of University Accreditations and Quality and the Dean of FASA are, each in his capacity, responsible for the implementation of this decision which shall be registered and published in English and French wherever necessary.
