Application files are received latest on the 14th of august 2020 at 15:30 prompt, in the Regional and Divisional Delegations of Employment and Vocational Training and in the chosen Rural Artisan and Home Economic Sections (RA-HES).

The files should include the following documents:

- an application form to be obtained free of charge from the Regional and Divisional Delegations of Employment and Vocational Training, Rural Artisan and Home Economic Sections (RA-HES), and to be downloaded from the website www.minefop.gov.com and MINEFOP Facebook page. The form will be stamped in the Regional or Divisional Delegation of Employment and Vocational Training by specialized services of the Ministry of Finance committed for the purpose ;
- a photocopy of the birth certificate;
- a photocopy of the required certificate and the school certificate to justify two (02) years secondary school ;
- a vaccination certificate ;
- a receipt for payment of the sum of two thousands (2000) CFA F as registration fees for the entrance examination issued by the authority receiving the files. No other form of payment will be accepted;
- 03 (three) recent colour 4x4 size photographs, two of which should be attached to the application form;
- an A4 size envelop (postage stamp) bearing the candidate's full address.
