To announce a direct competitive examination for the recruitment of 320 (three hundred and twenty) personnel into the corps of Rural Production (Agriculture) civil servants, for the 2020 session.

THE MINISTER OF THE PUBLIC SERVICE AND ADMINISTRATIVE REFORM,

Mindful of the Constitution;

Mindful of decree No.75/785 of 18 December 1975 on the special rules and regulations of the corps of Rural Production civil servants;

Mindful of decree No.94/199 of 7 October 1994 on the General Rules and Regulations of the Public Service, as amended and supplemented by decree No.2000/287 of 12 October 2000;

Mindful of decree No.2011/408 of 9 December 2011 to organize the Government, as amended and supplemented by decree No.2018/190 of 2 March 2018;

Mindful of decree No.2012/537 of 19 November 2012 to organize the Ministry of the Public Service and Administrative Reform;

Mindful of decree No.2018/191 of 2 March 2018 to reshuffle the Government;

Mindful of decree No. 2000/696/PM of 13 September 2000 to fix the General System of Government Competitive Examinations;

Mindful of letter No.B9/a-3/PM of 05 January 2018 authorizing the special recruitment of agricultural support staff,

HEREBY ORDERS AS FOLLOWS:

Article 1.- a) A direct competitive examination to recruit personnel into the corps of Rural Production (Agriculture) civil servants have been announced. The number of available places for the various categories is distributed as follows:

150 (one hundred and fifty) Senior Agricultural Technicians of the second grade of the "B" category of the Public Service;

150 (one hundred and fifty) Agricultural Technicians of the first grade of the "B" category of the Public Service:

20 (twenty) Assistant Agricultural Technicians of the "C" category of the Public Service.

b) The written part of this examination shall take place the MNISTRE October 2020 in Yaounde, the only examination centre.

Article 2.- REQUIREMENTS.

PRIME MINISTER'S OFFICE 1. General requirements: This examination shall be opened to all Cameroonians who fulfil the following conditions:

- a) fulfil all the requirements for admission to a public service employment and conditions laid down by the General Rules and Regulations of the Public Service;
- b) be physically apt to assume the duties of Rural Production;
- c) be at least 17 and at most 29 years of age as at 1st January 2020 (be born between 01/01/1991 and 01/01/2003) for candidates for the "C" category;
- d) be at least 17 and at most 34 years of age as at 1st January 2020 (be born between 01/01/1986 and 01/01/2003) for candidates for the "B" category.

2. Specific requirements:

For candidates for admission into the corps of Senior Agricultural Technicians, be holder of a Diploma of Senior Agricultural Technician or Senior Technicians in

For candidates for admission into the corps of Agricultural Technicians, be holder of a Diploma of Agricultural Technician, Diploma of Specialist in Cooperation, cycle "B" or Diploma of Specialist in Community Development, cycle "B" issued by a government national institution of training or by a recognized foreign or international institution of taining approved by Prime Minister's order.

or candidates for admission into the corps of Assistant Agricultural Technicians, be nolder of a Diploma of Assistant Agricultural Technician, Diploma of Specialist in Cooperation, cycle "C" or Diploma of Specialist in Community Development, cycle "C" issued by a government national institution of training or by a recognized foreign or

international institution of training approved by Prime Minister's order.

Aicle 3.- FILE COMPOSITION.

Candidates' complete application files shall be submitted, against a receipt, at the Ministry the Public Service and Administrative Reform, Department of State Human Resources evelopment, Service for Direct Competitive Examinations and Scholarship (4th floor, Rooms 15 and 409) or in all Regional Delegations of the Public Service, latest Friday 18 September p20. The files shall comprise the following documents:

- 1. a registration form bearing a CFA 1000 francs fiscal stamp. The forms can be obtained from the Ministry of the Public Service and Administrative Reform or at all Regional Delegations of the Public Service or downloaded at the following website address: http://www.minfopra.gov.cm;
- 2. a certified true copy of birth certificate signed by a competent civil authority;
- 3. a certificate of non-conviction;
- 4. a certified true copy of the required certificate signed by a competent civil authority:
- 5. an attestation of presentation of original of the required certificate signed by a competent civil authority;
- 6. a medical certificate issued by a public sector medical officer;
- 7. a receipt attesting payment of a registration fee of CFA 15 000 (fifteen thousand) francs issued by an EXPRESS UNION official at the place of submission of the application files;
- 8. 2 (two) passport-size photographs;
- 9. an envelope bearing a CFA 1000 francs stamp and the candidate's address. N.B:
 - The diploma of Senior Technician in Agro pastoral Counselling issued by the Ministry of Livestock, Fisheries and Animal Industries shall not be accepted.
 - · State employee candidates governed by the Labour Code who meet the conditions set out in Article 2 shall provide a copy of their contract or decision of employment.
 - All incomplete or late files or files containing documents signed by the police shall be rejected.
 - · All documents should be certified by a competent June Hampa MINISTER authorities and not more than 3 (three) months old.


