HEREBY ORDERS AS FOLLOWS:

Article 1.- a) A direct competitive examination to recruit personnel into the corps of Surveys civil servants have been announced. The number of available places for the various categories is distributed as follows:

For candidates for admission into the cadre of Assistant Surveys Engineer, be holder of a Diploma of Assistant Geodesy Engineer, Photogrammetrist, Topographical Surveyor, Surveyor or Cartographer issued by a national institution of training or by a recognized foreign or international institution of training featuring on the list approved by Prime Ministerial order.

For candidates for admission into the cadre of Senior Surveys Technician, be holder of a Diploma of Senior Topographical Survey Technician issued by a national institution of training or by a recognized foreign or international institution of training featuring on the list approved by Prime Ministerial order.

For candidates for admission into the cadre of Surveys Technician, be holder of a Diploma of Topographical Survey Technician issued by a national institution of training or by a recognized foreign or international institution of training featuring on the list approved by Prime Ministerial order.

For candidates for admission into the cadre of Assistant Surveys Technician, be holder of a Diploma of Assistant Topographical Survey Technician issued by a national institution of training or by a recognized foreign or intermeter burget en of training

featuring on the list approved by Prime Ministerial order.

Article 3.- FILE COMPOSITION.

 - 8. 2 (two) passport-size photographs;
 - an envelope bearing a CFA 1000 francs stamp and the candidate's address.

- All incomplete or late files or files containing documents signed by the Police shall be rejected;
