To announce a direct competitive examination for the recruitment of 86 (eighty-six) personnel into the corps of Posts and Telecommunications Operations civil servants, for the 2020 session.

HEREBY ORDERS AS FOLLOWS:

Article 1.- a) A direct competitive examination to recruit personnel into the corps of Posts and Telecommunications Operations (Financial and Postal Services and, Telecommunications Operations) civil servants have been announced. The number of available places for the various categories is distributed as follows:

I- Financial and Postal Services:

- 10 (ten) Posts and Telecommunications Administrators of the first grade of the "A" category of the Public Service;
- 20 (twenty) Posts and Telecommunications Inspectors of the first grade of the "A" category of the Public Service;
- 16 (sixteen) Posts and Telecommunications Controllers of the first grade of the "B" category of the Public Service.

II- Telecommunications Operations:

- 20 (twenty) Posts and Telecommunications Inspectors of the first grade of the "A" category of the Public Service;
- 20 (twenty) Posts and Telecommunications Controllers of the first grade of the "B" category of the Public Service.

b) The written part of this examination shall take place on the 10 and 11 October 2020 in Yaounde, the only examination centre.

Article 2.- REQUIREMENTS.

1. General requirements:

This examination shall be opened to all Cameroonians who fulfil the following conditions:

- a) fulfil all the requirements for admission to a public service employment and conditions laid down by the General Rules and Regulations of the Public Service;
- b) be physically apt to assume the duties of Posts and Telecommunications Operations ;
- c) be at least 17 and at most 34 years of age as at 1st January 2020 (be born between 01/01/1986 and 01/01/2003).

2. Specific requirements:

- For candidates for admission into the grade of Posts and Telecommunications Administrator, be holder of a Diploma of Posts and Telecommunications Administrator or a required equivalent certificate issued by a national institution of training or by a foreign or international school featuring on a list approved by a Prime Minister's order.
- For candidates for admission into the grade of Posts and Telecommunications Inspectors, be holder of a Diploma of Posts and Telecommunications Inspector or a required equivalent certificate issued by a national institution of training or by a foreign or international school featuring on a list approved by a Prime Minister's order.
- For candidates for admission into the grade of Posts and Telecommunications Controllers, be holder of a Diploma of Posts and Telecommunications Controllers or a required equivalent certificate issued by a national institution of training or by a foreign or international school featuring on a list approved by a Prime Minister's order.

Article 3.- FILE COMPOSITION.

Candidates' complete application files shall be submitted, against a receipt, at the Ministry of the Public Service and Administrative Reform, Department of State Human Resources Development, Service for Direct Competitive Examinations and Scholarship (4th floor, Rooms 405 and 409) or in all Regional Delegations of the Public Service, latest Friday 25 September 2020. The files shall comprise the following documents:

1. a registration form bearing a CFA 1000 francs fiscal stamp in which the candidate specify his or her specialty (Financial and Postal Services or, Telecommunications Operations). The forms can be obtained from the Ministry of the Public Service and Administrative Reform or at all Regional Delegations of the Public Service or downloaded at the following website address: <http://www.minfopra.gov.cm>;
2. a certified true copy of birth certificate signed by a competent civil authority;
3. a certificate of non-conviction;
4. a certified true copy of the required certificate signed by a competent civil authority;
5. an attestation of presentation of original of the required certificate signed by a competent civil authority;
6. a medical certificate issued by a public sector medical officer;
7. a receipt attesting payment of a registration fee of CFA 15 000 (fifteen thousand) francs issued by an EXPRESS UNION official at the place of submission of the application files;
8. 2 (two) passport-size photographs;
9. an envelope bearing a CFA 1000 francs stamp and the candidate's address.

N.B:

- State employee candidates governed by the Labour Code who meet the conditions set out in Article 2 shall provide a copy of their contract or decision of employment.
- All incomplete or late files or files containing documents signed by the police shall be rejected.
- All documents should be certified by a competent civil, municipal or legal authorities and not more than 3 (three) months old.

The Minister of the Public Service and Administrative Reform shall announce through a press release, the date and timetable for the oral part.


