To launch the Competitive Entrance Examination into the first year of the Faculty of Agriculture and Veterinary Medicine of the University of Buea and fixing the number of places offered for the 2020/2021 academic year.

Mindful of Decree n°93/034 of 19<sup>th</sup> January 1993 to organize the University of Buea;

Mindful of Decree no 2017/318 of 27<sup>th</sup> June 2017 appointing the Vice-Chancellor of the University of Buea;

Mindful of Decree n° 2019/447 du 27 August 2019 appointing the Dean of the Faculty of Agriculture and Veterinary Medicine;

Mindful of Arrête n° 20/00407/MINESUP/SG/DAUQ/SDEAC/SE of 26<sup>th</sup> May 2020 fixing the calendar of the competitive examinations into the Cameroon State Universities, for the 2020/2021 academic year;

## **DECIDES AS FOLLOWS:**

Article 1: A Competitive Entrance Examination for the selection of three hundred students for admission into the first year of the Faculty of Agriculture and Veterinary Medicine (FAVM) of the University of Buea for the 2020/2021 academic year, will take place on the following date and at the centres indicated below:

Date: Wednesday, 23 September 2020

Centres: Buea, Bamenda, Douala and Yaoundé

The 300 places shall be distributed to programmes as follows:

<u>Article 2</u>: The Competitive Entrance Examination cited in article 1 shall be open to male and female Cameroonians and to foreign candidates' resident in Cameroon within the limits of available places.

<u>Article 3</u>: Applicants for the competitive entrance examination must be holders of one of the following qualifications:

- General Certificate of Education Ordinary Level in at least five subjects including English Language, Mathematics, Biology and Chemistry; and General Certificate of Education Advanced Level in at least two subjects which must include two of the following Biology, Chemistry, Physics, Mathematics and Food Science;
- Baccalaureat D;
- Any other certificates recognized as equivalent by the Ministry of Higher Education;

Article 4: The complete application file must include the following documents:

- 1) An application form to be completed online by the applicant. The application form which is found on the University of Buea website: <a href="www.ubuea.cm">www.ubuea.cm</a> should be completed no later than Saturday, 19<sup>th</sup> September 2020. Late or incomplete application files shall be rejected;
- 2) Certified true copy of the candidate's birth certificate not less than three (3) months old;
- 3) Four (4) recent passport-size photographs (4cm x 4cm);
- 4) Photocopies of the relevant academic certificates indicated in Article 3 above;
- 5) Receipt of payment of CFAF 20,000 (twenty thousand francs) for the examination, payable to the following account at **Banque Atlantique Cameroon**:

Article 5: All documents mentioned in Article 4: 2), 3) and 4) above should be scanned and emailed to the address: favm.ub@ubuea.cm

<u>Article 6</u>: The examination centres are Buea, Bamenda, Douala and Yaounde. A press release published by the Vice-Chancellor of the University of Buea shall ultimately indicate the modalities of the organization of the written examination.

<u>Article 7</u>: Candidates are requested to come to the examination centres at least 30 minutes before the start of each examination paper. They must come along with their National Identity card.

<u>Article 8</u>: The written papers below will account for 60% and study of files 40%. The written examination is based on the High school syllabus and will comprise:

- Biology (3 hours)
- Chemistry (3 hours)

<u>Article 9</u>: The results of the examination shall be prepared by a panel appointed by the Minister of Higher Education, on the proposal of the Vice-Chancellor of the University of Buea.

Article 10: The list of successful candidates shall be published by the Minister of Higher Education.

Article 11: The Vice-Chancellor of the University of Buea, the Director of University Accreditation and Quality and the Dean of the Faculty of Agriculture and Veterinary Medicine of the University of Buea shall be responsible, each in his/her own sphere, for the implementation of this decision which shall be registered and published wherever need be.
