DECISION N° 19 82 00 26 3 /MINESUP/SG/DAUQ/SDEAC OF 12 9 JUL 2020
ANNOUNCING A COMPETITIVE ENTRANCE EXAMINATION FOR ADMISSION INTO THE MASTER
PROFESSIONNEL CYCLE OF THE REGIONAL TRAINING CENTER SPECIALIZED IN AGRICULTURE (CRESA)
FORESTRY AND WOOD IN THE FACULTY OF AGRONOMY AND AGRICULTURAL SCIENCES (FASA) OF THE
UNIVERSITY OF DSCHANG FOR THE 2020/2021 ACADEMIC YEAR.

THE MINISTER OF STATE, MINISTER OF HIGHER EDUCATION,

- Mindful of the Constitution;
- Mindful of Law of n°005 of 16 April 2001 on the orientation of Higher Education;
- Mindful of Decree n°2004/320 of 08 December 2004 appointing members of Government modified and completed by Decree n°2007/268 of 7 September 2007, and Decree n° 2009/223 of 30th June 2009 ;
- Mindful of Decree n°2005/142 of 29 April 2005 organising the Ministry of Higher Education;
- Mindful of Decree N°93/026 of 19 January 1993 creating Universities ;
- Mindful of Decree N°93/027 of 19 January 1993 modified and completed by Decree n°2005/342 of 10 September 2005 laying down provisions common to all Universities ;
- Mindful of Decree N°93/032 of 19 January 1993 laying down financial regulations governing Universities ;
- Mindful of Decree n° 93/029 of 19 January 1993 laying down the administrative and academic structures of the University of Dschang;
- Mindful of Decree N ° 2015/398 of 15 September 2015 appointing Rectors in certain state universities;
- Mindful of the Protocol Agreement between ACCT, AUPELF-UREF and the Ministry of Higher Education of 16th of July 1993, laying down their role in the creation and functioning of the Regional Training Center for specialized training in Agriculture (CRESA) Forestry and Wood at the University of Dschang;
- Mindful of the agreement in principle to open the EIA sector of No. 05/1336 / L / MINESUP / DDES / PEEX / esc of March 22, 2005;
- Mindful of Order N°20-00407/MINESUP/SG/DAUQ/SDEAC/SE of 26 May 2020 modifying the order N° 20/00106/MINESUP/SG/DAUQ/SDEAC/SE of 17 March 2020 to organize the calendar of competitive entrance examinations into Faculties, Schools and Institutions of Cameroon State Universities for 2020-2021 academic year;
- On the proposal of the Rector of the University of Dschang ;

HEREBY DECIDES AS FOLLOWS:

Article 1^{er}: A competitive entrance examination based on study of files is open for admission of sixty five (65) students into the fifth year of the **PROFESSIONAL MASTER** cycle of the Regional Training Center of Specialized study in Agriculture (CRESA) of the Faculty of Agronomy and Agricultural Sciences (FASA) of the University of Dschang for the 2020/2021 academic year.

Article 2: This competitive entrance examination concerns the three following programs:

1. Industrial Valorisation of wood
2. Participatory Management of Forest Resources
3. Environnemental Impact Assessment.

The 65 places opened are distributed as follows:

- 10 for Industrial Valorisation of wood
- 25 for Participative Management of Forest Resources
- 30 for Environnemental Impact Assessment.

Article 3 :

(1) The entrance examination is open to candidates of both sexes, Cameroonians and Citizens of other African francophone countries and Indian Ocean mastering perfectly French language. There is no age limitation.

(2) Candidates should commit themselves to pay tuition fees of 1,000,000 (one million) CFA F, and other charges of their cost of living.

(3) The training in CRESA is at the fifth year level of the PROFESSIONAL MASTER, and last one year (12 months). Candidates must be holders either of a Master I (Maîtrise), or an Engineer diploma (**BAC + 4 years or more**), or an equivalent Certificate in the following fields:

- *For Industrial Valorisation of wood*
 - Engineering sciences : civil engineering, mechanical engineering, industrial engineering,
 - Forest Sciences
 - Forest Engineering,
- *For Participative Management of Forest Resources*
 - Forest Engineering
 - Plant Biology
 - Geography
- *For Environnemental Impacts Assessment*
 - Environnemental Sciences,
 - Physics
 - Chimistry
 - Forestry
 - Agronomy,
 - Economics
 - Law,
 - Humanities: Geography, Sociology, Anthropology, Psychology.
 - Soil Sciences
 - Engineering sciences

Article 4: The application file will include the following:

- form to be completed online on the University of Dschang website: <https://sigesonline.univ-dschang.org>;
- a copy of birth certificate dating from less than 3 (three) months,
- two identity photos (4x4),
- a medical certificate,
- certified photocopies of university diplomas obtained,
- certified true photocopies of transcripts relating to these diplomas,
- for civil servant candidates, a letter of authorization to present the candidacy duly signed by the employer
- an envelope (A4 format) stamped by a post office to the weight of the attachments and bearing the address of the candidate,
- a payment receipt of 20,000 representing the competition fees payable in one of the microfinances chosen on the site indicated above.

The dateline for application is **Friday 20 of September 2020.**

Article 5.- Only candidates with a full and complete application file will be considered.

Article 6.- the competitive examination on the basis of the study files is based on the evaluation of the candidate's past performance on the following criteria.

- Transcripts of the highest university degree obtained ;
- University course of study (class repeated);
- Academic internships;
- Academic dissertation;
- Professional seniority;
- Thematic project in the requested sector (justification, objectives, methodology, expected results, etc.), motivations and prospects.

Article 7:

1) The results will be compiled and prepared by a panel appointed by the Minister of State, Minister of Higher Education on the proposal of the Rector of the University of Dschang.

2) Final results are published by the Minister of State, Minister of Higher Education

Article 8: The Rector of the University of Douala, the Director of University Accreditations and Quality, and the Director of CRESA Forêt-bois of Dschang, each in his own sphere, are responsible for the implementation of the present decision which shall be registered and published in English and in French wherever necessary./-
