To launch the competitive examination for admission into the First year of the Division of Initial Training at the University Institute of Technology (UIT) of the University of Douala and to decide on the number of places available, for the 2021/2022 academic year.

ANNOUNCES:

Article 1: A competitive entrance examination for the admission of five hundred and ninety three (593) students into the 1st year of Specialities in Industrial Technologies (SIT), Tertiary Technologies (STT), Information and Digital Technologies (SIDT) of the Division of Initial Training of the University Institute of Technology of the University of Douala, for the 2021/2022 academic year, shall take place on 9th July 2021.

Article 2: The competitive entrance examination is opened to Cameroonian and foreigners of both sexes, not more than twenty-nine (29) years old on January 1st, 2021.

Article 3: The number of available places is five hundred and ninety three (593) allocated as follows:

Article 4: The complete application file should comprise the following documents:

- 1) A registration form to be duly **filled online** in the Web site of UIT of Douala: www.iut-douala.cm, printed and signed by the candidate, and stamped at CFAF 1,000;
- 2) A certified true **photocopy** of the birth certificate issued within the last three (03) months;
- 3) A certified true copy of the required diploma;
- 4) A certificate of school attendance for “Terminale” or Upper 6th;
- 5) A medical certificate issued within the last three (03) months by a state medical practitioner, and testifying that the candidate is fit for higher education;
- 6) Four (04) recent passport-size photographs of the candidate;
- 7) A **twenty thousand (20,000)** CFA francs banking receipt representing examination fees to be paid at the UBA account N° 10033 05214 14004000006 – 90, or at the BICEC account N° 01253101002-18
- 8) A 21 x 29.7 size self-addressed envelope bearing a 400 CFA francs postal stamp;
- 9) The competitive entrance examination is open to Cameroonians and foreigners of both sexes, not more than twenty-nine (29) years old on January 1st, 2021.

Article 5: Application files must be submitted latest on 7th July 2021 at the following places:

- The Ministry of Higher Education/ Direction of University Accreditation and Quality (DUAQ);
- Admissions Office of the Douala University Institute of Technology;
- The Regional Delegations of the Ministry of Secondary Educations of the various examination centres listed in section 8;

Application forms can also be downloaded from the websites of the Ministry of Higher Education www.minesup.gov.cm or of the UIT of Douala www.iut-douala.cm.

Article 6: The written examination will take place on the 9th July 2021 at the centres indicated in section 8.

Article 7: The written examination in each specialty consists of the following papers:

Mathematics	3	2 hours
Speciality paper	3	2 hours

The papers are based on the syllabus of “Terminale” and Upper Sixth forms preparing for the certificates indicated in section 3 of this announcement.

Article 8: The competitive entrance examination for admission into the 1st year of the University Institute of Technology (IUT) of the University of Douala for the 2021/2022 academic year will take place in the following centres: **Bafoussam, Bamenda, Bertoua, Buéa, Douala, Ebolowa, Edéa and Yaoundé.**

Article 9: A press release published by the Rector of the University of Douala shall ultimately indicate, as necessary, for each examination centre the place and the planning of the various papers.

Article 10: Candidates are requested to come to the examination centres at least 60 minutes before the beginning of the first paper. They must come along with their National Identity cards or any other authentic valid identification document.

Article 11: Successful candidates shall report to UIT for registration formalities within **fifteen days** following the date of publication of the final results. Candidates who fail to comply with this requirement, shall be replaced by those on the waiting list, following the order of merit, through a press release published by the Minister of Higher Education on the recommendation of the Rector of the University of Douala.

Article 12: The Rector of the University of Douala, the Director of University Accreditations and Quality, and the Director of UIT of Douala, each in his own sphere, are responsible for the implementation of the present press release which shall be registered and published in English and in French wherever necessary./-
