**HEREBY ANNOUNCE:**

**ARTICLE 1:** A competitive entrance examination into **year one** of the first cycle for the University Technology Diploma of **Industrial Fishing** (Fishing-Navigation and Vessel equipment), **Marine engineering** (Maintenance of Ships, Nautical and Industrial Equipment), **Aquaculture and Fisheries Technology** of the Limbe Nautical Arts and Fisheries Institute (LINAFI), for the 2021/2022 academic year is organized in the following centres: Douala, Limbe, Garoua, and Yaoundé.

**ARTICLE 2: GENERAL CONDITIONS**

The competitive entrance examination is opened to Cameroonians of both sexes who are holders of the following certificates: GCE Advanced Level in at least two (2) papers in sciences. Baccalauréat C, D, E, F, Brevets de Techniciens Industriels except Textile Industry or any other equivalent certificate recognized by the Ministry of Higher Education.

Those awaiting results are eligible to apply.

The age limit for candidates is between:

- ✓ 18 and 35 years for Industrial Fishing and Marine Engineering.



- ✓ 18 and 40 years for Aquaculture and Fisheries Technology.

- At all Regional Delegations of the Ministry of Livestock, Fisheries and Animal Industries, or to be downloaded at the websites of LINAFLI <http://www.linafi.cm>, MINESUP <http://www.minesup.gov.cm> ; and MINEPIA <http://www.minepia.gov.cm>
- A photocopy of national identity card or its receipt;
- A certified true copy of the Birth Certificates dated not more than three (03) months;
- A certified true copy of the corresponding certificates dated not more than three (03) months;
- A certified true copy of non-conviction dated not more than three (03) months;
- Two passports size photographs;
- An authorization to sit for the examination issued by the user ministry (for civil servant);
- A medical certificate issued by a medical officer from the administration and testifying that the candidate is physically and mentally fit for sea profession;
- One self-addressed A4 envelope bearing a stamp of 500 CFA;
- A receipt upon payment of **twenty thousand (20.000) CFA** as registration fees delivered by **BICEC BANK** to be deposited on account N° **10001068406351014000104**.

ARTICLE 9: Examination registration fees are non-refundable.



**ARTICLE 10:** Only candidates who have submitted a complete and regular file shall be authorised to sit for the examinations.

**ARTICLE 11:** The results of the examinations shall be published by a communique of the Minister of State, Minister of Higher Education and the Minister of Livestock, Fisheries and Animal Industries.

**ARTICLE 12:** The orals for successful candidates will take place on the 7<sup>th</sup> and 8<sup>th</sup> October 2021 in the Limbe centre exclusively.

**ARTICLE 14:** Candidates from foreign countries who are recruited will only be definitively admitted after a medical test.

**ARTICLE 15:** The Director of Limbe Nautical Arts and Fisheries Institute "LINAFI" and the Director for University Accreditations and Quality, are each in his capacity, responsible for the implementation of this Press release, which shall be registered, published and broadcast wherever need be./-
