HEREBY ORDERS AS FOLLOWS:

Article 2: The examination shall be open to all Cameroonia Southout distinction of language (English or French) who fulfil the following requirements: (English or French) who fulfil the following requirements:

- for the Judicial and administrative sections; be a holder of a Master's Degree or "Maîtrise" in private or public Law issued by a Cameroonian university or any other foreign equivalent certificate, recognized by the competent authority and accepted by the Ministry of Higher Education:
- for the Accounts Section; be a holder of either a Master's Degree or "Maîtrise" in Law, in Economics, Management or a Master's Degree in Computer Science issued by a Cameroonian university or any other foreign equivalent certificate, recognized by the Ministry of Higher Education:
- be at least 17 (seventeen) years of age and 32 (thirty-two) years at most, as at 1st January 2021.

- a receipt attesting the payment of the registration fee, issued by the Accounting Officer of ENAM for candidates submitting their files in Yaounde or the Regional Delegations of the Ministry of Public Service and Administrative Reform for other applicants;
- a certificate of non-conviction of not more than 03 (three) months old signed by the competent judicial authorities;
- a medical certificate of not more than 03 (three) months old signed by a medical doctor of the public sector;
- a certified true copy of a birth certificate handwritten or typed- signed by the competent administrative or council authorities.

7) The list of candidates authorized to sit for the competitive entrance examination shall be set and posted at ENAM on **Wednesday 18 August 2021** at the latest.






Article 6: All National Identity Card receipts obtained less than three months before the latest date of registration for this competitive entrance examination shall not be accepted.
